OMU TREE GIVEAWAY

Recently, we have found many signs of emerald ash borer infestations in our area. The emerald ash borer is a parasite that slowly destroys ash trees from the inside. They feed on the tissues under the bark of ash trees. Signs that your ash tree may have emerald ash borers include S-shaped or D-shaped holes in the bark; canopy dieback; bark splitting; and increased woodpecker activity.

Each year in the spring, OMU has an annual tree giveaway for our utility customers. It was decided at a recent OMU Board of Trustees meeting that our tree program would be temporarily suspended to help our customers with the emerald ash borer problem. We will be offering to our customers that have a tree(s) removed due to infestation or location to our electrical lines, the opportunity to purchase a tree to replace the one(s) removed by OMU. These customers can purchase a tree of their choice from an approved list of trees suited for our area.

To qualify for reimbursement, the tree(s) must have been removed by OMU; a call to lowa One Call to have all underground services marked has been done; and you must be an OMU electric customer. OMU will give you a credit on your electric bill of 50% of the cost of a tree up to \$50 based on proof of purchase. An air conditioner tune—up is a preventative maintenance service that prepares your air conditioner for increased use in warmer months. It ensures key components are running well and that the AC system is running at peak performance. During an AC tune—up, a professional comes to your house to inspect your indoor and outdoor AC components.

Osage Municipal Utilities will offer a \$20.00 credit against your utility bill to any customer who contracts for an air conditioning tune—up with one of the following plumbing, heating, or electrical contractors:

To qualify for your credit, have your contractor complete the Osage Municipal Utilities check list after they perform your central air conditioning tune—up. OMU's Voluntary Solar Program is a community based solar project open to OMU electric customers. Eligible customers may participate by choosing to purchase units of Solar Array capacity in return for the right to receive a production-related credit on their monthly utility bill. Customers choose their level of investment with no on-going maintenance costs. Participating customers are not purchasing physical equipment, but rather the right to receive a credit associated with their share of the output produced by the Solar Array. Please contact our office at 641-832-3731 for more information.

Please be advised, customers that elect to purchase solar panels or any other electric generating facilities for their own residence need to contact OMU prior to doing so.



You must contact Iowa One Call at least 48 hours in advance when planning to excavate. This does not include holidays and weekends. A One Call ticket is valid for 20 calendar days from the time of the call. **ALWAYS** check yard markings and Iowa One Call Positive Response ticket status before beginning excavation. Only buried facilities registered with Iowa One Call will be located and marked. Private facilities, like LP gas lines, sprinkler systems, gas grill lines, etc will not be marked. Paint and flag markings are approximate, and the tolerance zone is 18" on either side of the markings. You should hand dig with caution in the tolerance zone.
